# Finance Committee Recommendationsto Council

# Call Committee:

## Financials:

• Receipts year to date are almost up to budget. Still behind, but progress has been made. Expenses are still running behind, but January expenses caught up.

## **Update on Budget Process:**

- Maintenance, staff raises and paying back borrowing against designated funds have not been budgeted in the past. Health care will go up in January. That will run a1.6 million dollar budget. Our current budget is 1.5. More than a 5% increase. That feels unmanageable. We have to look at cuts somewhere. Still a tough budget picture.

## Finance Committee Recommendations to Council February 10, 2015

Following a meeting held on February 10, 2015, the Finance Committee made the following recommendations to council:

## **Request for Funds to Redesign the Gifting Brochure**

The Finance Committee recommends that council should wait on a re-design and reprint of the designated gifting brochure, currently being studied by the Design team, until such time as the policy and procedure surrounding how RLC accepts and accounts for designated gifts is studied and likely revised.

## Restrain Spending Over the Balance of the Year

The finance recommends that council direct Laurel directs the staff and ministry teams to restrain spending over the balance of the year, where possible, by spending only amounts budgeted for the remaining of the year.

The finance committee further recommends that council ask M&O to spend 75% of what they would otherwise spend on a monthly basis for the balance of the year, until such time as our 2014-2015 financial results become clear. If we end the fiscal year at break even or better, the remaining 25% will be released for M & O disbursements. The finance committee believes that since other ministries are being asked to restrain spending, so too should M&O.

## Review of M&O Ministry

The finance committee recommends that council commission a comprehensive review of RLC's Mission and Outreach ministry with the goal of addressing several key questions.
